EQUINE WELLNESS PLAN

Terms & Conditions

When joining the Station House Vets Equine Wellness Plan you are accepting these terms and conditions. It is important to read them carefully, and please ask a member of staff if you have any queries.

If you would like a copy of these terms and conditions in larger print – please ask at reception.

1. The Station House Vets Equine Wellness Plan is a rolling annual preventative healthcare programme. The Station House Vets Wellness Plan is not an insurance policy.
2. Membership of the agreement constitutes an agreement between you and Great and Small Limited. Membership and benefits are not transferable to another practice.
3. You will receive discounted products and services during the course of your membership including, but not limited to, one annual vaccine / worming / dental treatments and a full health check with one of our team. Full details of what is included are available in the Appendix below.
4. Of course, your horse can still receive treatment outside the scope of the Station House Vets Equine Wellness Plan and this will be charged in accordance with the practice's normal fees, terms and conditions.
5. These Station House Vets Wellness Plan terms and conditions should be read in conjunction with any additional information including, but not limited to, literature provided by the practice detailing what is included in the Station House Vets equine Wellness Plan. That literature forms part of these terms and conditions.
- 6. Your responsibilities** – you are responsible for following our vets' and nurses' guidance, and for horses healthcare. If we are unable to maintain your horses's health because you haven't followed guidance we may need to terminate your membership. Termination would be in writing as outlined below, and with immediate effect.
7. Your membership fees will be collected by Direct Debit or by a nominated bank card on a monthly basis. Your membership will begin only when your direct debit or 1st card payment is successful.
8. We use Vet Success Limited to collect Direct Debits on our behalf, and your bank statements will show a payment to BPS re Vet Success. For the avoidance of doubt, your agreement is with Great and Small Limited. Vet Success Limited merely provide support to the practice, which includes transferring your payments.
9. Membership for each horse will renew automatically on the anniversary of the date that your horse joined the Station House Vets Wellness Plan.
10. We will tell you in advance, in writing, if there is to be a change in membership fees on your renewal date. We will always give you at least 30 days' notice of any change in fees as a result of our annual review.
11. Failed Direct Debit payments, eg because of a lack of available funds, cause a significant increase in administration costs for the practice. We reserve the right to charge an administration fee of £10 for each failed payment. This administration charge will be added to your account.
12. After a failed Direct Debit payment, we will re-present our payment request to your bank after 3-5 working days.
13. If the second payment request also fails, a second administration charge may be added to your account. We will make a third and final payment request to your bank after a further 3-5 working days. If this payment request is unsuccessful your Station House Vets Equine Wellness Plan membership will be cancelled automatically and your horse will no longer receive the associated benefits and discounts.
14. If your Station House Vets Wellness Plan membership is cancelled automatically because of failed direct debits, your account will be reviewed and you will be charged the full price of any products and services received during the course of your membership, minus any membership fees received to date.

15. Ending our agreement / cancelling your membership:

- You may cancel your membership on your anniversary date (which is the anniversary of the date you joined) by giving us not less than two weeks' notice.
- If you cancel your membership before your anniversary date, we will carry out a reconciliation of your account and, where applicable, charge you for the remainder of your annual subscription up to your anniversary date. We will also charge you an admin reconciliation fee of £25. This balance will be charged to your account and will be due immediately.
- We may end our agreement by giving you written notice as outlined below.

16. Unpaid bills relating to your membership fees, treatment received or medicines dispensed will be handled in accordance with our standard terms and conditions (available on request) and may be referred to a third party debt collection agency.

17. Notice:

- With regard to this agreement, either party wishing to give notice to the other should do so in writing.
- 'In writing' includes emails, letters sent by post, or delivered by hand.
- When we write to you by post, we will use the address most recently provided.
- If you wish to write to us, please use the email address accounts@stationhousevets.co.uk or send letters to Station House Vets Wellness Plan Administration, Teal House, Welburn, York YO60 7EP.

18. Should you ever have cause to complain about the service you receive, please follow the practice's normal complaints procedure (available on request).

How we use your information

19. Vet Success Limited and Station House Vets will hold and use your personal data (as defined by UK data protection laws) for the purpose of administering your preventative healthcare plan.

20. Both Station House Vets and Vet Success Limited may record and monitor inbound and outbound telephone calls for training purposes. These calls may also be referred to in relation to any future queries.

21. We will take all reasonable precautions to ensure the security of your data. Your data will not be shared with anyone else unless there is a legal requirement for us to do so.

22. You have the right to see your personal data. If you have any queries about the data we hold, or how we use it, please write to either Station House Vets, Teal House, Welburn, York YO60 7EP.

23. We reserve the right to increase the monthly payment shown on your registration form in our absolute discretion provided that we give you not less than one month's notice in writing of such increase. If you do not agree with the increase you may terminate your membership with immediate effect by notifying Great and Small Limited in writing within 2 weeks of receiving notice of the increase.

24. We reserve the right to amend the products and services and discounts within the Station House Vets Equine Wellness Plan at our absolute discretion provided that we give you not less than one month's notice in writing of such amendment. If you do not agree with the amendment you may terminate your membership with immediate effect by notifying Great and Small Limited in writing within 2 weeks of receiving notice of the alteration.

NOTES ON THE PLAN

Please note that it is your responsibility to utilise the benefits listed below that are applicable to your Equine Wellness Plan membership. You shall not be entitled to any refund in respect of unused benefits.

Equine Wellness Plan

What's Included:

- 1 x annual vaccination (equine influenza or equine influenza plus tetanus)
- 50% off up to two dentals per annum (with or without sedation)
- 10% off equine wormers purchased from and recommended by us
- 10% off Equine America and Hestevard supplements purchased from us
- 10% off chronic medications, including Danilon, Equipalazone, Equioxx, Prascend, Ventipulmin, Dilaterol, and Subestin
- 3 x faecal worm egg counts
- 1 x resistance worm egg count
- 1 x tapeworm saliva test

Vaccinations

The Equine Wellness Plan includes the cost of one vaccination per year for equine influenza or equine influenza plus tetanus. If both equine influenza and tetanus are required, they must be administered at the same time and not separately.

If your horse requires a restart of its vaccination course, only one of the three vaccinations is included in the plan.

Equine Herpesvirus, Strangvac, and any other vaccinations are not included in the plan and will be charged as normal.

Dentals

The scheme includes 50% off two routine dental examinations and floats per annum, with or without sedation, carried out by a Station House Vets veterinary surgeon.

Any complex dentistry, including diastema flushing or extractions, is not included and will be charged separately. If repeated sedation is required, this will also be charged accordingly.

Equine Wormers

Wormers prescribed and purchased directly from us include a 10% discount.

Supplement Discount

Hestevard and Equine America supplements purchased directly from us include a 10% discount.

Other supplements are not eligible for discounts. Supplements purchased online using our vet code will also not receive any discount.

Chronic Medication Discounts

A 10% discount applies to the following medications used to manage chronic diseases: Danilon, Equipalazone, Equioxx, Prascend, Ventipulmin, Dilaterol, and Subestin.

These medications must be prescribed and purchased directly from us to qualify for the 10% discount. Any medications purchased online will not receive a discount.

Worm Egg Counts

Three faecal worm egg counts are included, plus one faecal worm egg count resistance test if required.

Any additional faecal worm egg counts will be chargeable. If samples require external laboratory testing, additional fees will apply.

Tapeworm Saliva Test

One tapeworm saliva test is included per year. If the tapeworm test is inconclusive, a replacement test will be chargeable.

Visit Fees

Standard visit fees apply to all visits unless the yard scheme applies.

Visit fees are waived where five or more horses on the same yard are seen by a Station House Vets clinician during the same visit. The visit fee waiver applies to the visit charge only and does not affect the cost of any treatments, medications, or procedures carried out during that visit.
